NetVizura - Free Academic License Agreement (FALA)

This Free Academic License Agreement ("FALA" or "Agreement") is effective ____

BETWEEN: Soneco d.o.o., a company organized and existing under the laws of the Republic of Serbia, with its head office located at: Makenzijeva 24/VI, 11111 Belgrade, Serbia.

AND: ______, an academic institution organized and existing under the laws of the ______ of _____, with its head office located at: ______.

The parties hereto agree as follows:

1. Parties. This software license agreement (the "Agreement" or "FALA") is entered into by and between software provider ("Licensor", "Soneco" or "us") and Academic Institution ("Licensee", "Public Academic Institution" or "you").

2. Right to Use Software. Soneco hereby grants to publicly funded Academic Institution a worldwide, nonexclusive, nontransferable, non-assignable and limited right to use the NetVizura NetFlow Analyzer software and it's documentation ("Software").

3. Use Restrictions. Licensee shall not: (i) sell, redistribute, encumber, give, lend, rent, lease, sublicense or otherwise transfer the Software, or any parts of the Software, to anyone without the prior written consent of Soneco; (ii) reverse engineer, decompile, disassemble, modify, translate, make any attempt to discover the source code of the Software; (iii), create any derivative works of the Software or documentation, including customization, translation or localization; (iv) remove or alter any trademark, logo, copyright or other proprietary notices, legends, symbols or labels in the Software;

4. Obligations of Licensee. Licensee agrees that Soneco has the right to refer to Licensee and its use of the Software, on web site and in other marketing materials. Licensee agrees to: (i) provide a back-link to www.netvizura.com web site from a suitable public page on Licensee's web site (such as a "Partner", or "Tools" page), (ii) place objective quotation of experience with NetVizura NetFlow Analyzer on selected review portals and (iii) provide product usage feedback in a yearly questionnaire.

5. Obligations of Soneco: Soneco will provide Licensee with one-year License key limited to 500 fps, initial support necessary for proper implementation of the Software, updates and update related support.

6. Term. The term of this Agreement shall commence from the date and will continue to exist for the limited term of one year. After each term expires, obligations of the Licensee will be reviewed by Soneco and upon it's fulfillment new one-year term will be automatically renewed.

7. Termination. The Agreement shall automatically terminate if Licensee violates any of the above terms. Either party may also terminate this Agreement for any reason or no reason at all, by giving thirty (30) days prior written notice to the other party. Upon any such termination, Licensee shall immediately cease to use the Software and certify in writing that all copies of the Software have been destroyed from the Licensee's computers.

8. Disclaimer of Warranty. THE SOFTWARE IS PROVIDED ONLY FOR ACADEMIC PURPOSES ON AN "AS IS" BASIS. LICENSOR EXPRESSLY DISCLAIMS ALL WARRANTIES, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT.

9. Limitation of Liability. IN NO EVENT WILL LICENSOR BE LIABLE FOR ANY DAMAGES, INCLUDING LOST PROFITS OR DATA, OR OTHER INCIDENTAL OR CONSEQUENTIAL DAMAGES, ARISING OUT OF THE USE OR INABILITY TO USE THE SOFTWARE OR ANY DATA SUPPLIED THEREWITH, EVEN IF LICENSOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, OR FOR ANY CLAIM BY ANY OTHER PARTY.
